- **I. Call to Order:** E. Dias called meeting to order at 3:36 p.m.

- III. Approval of April 8, 2024 Meeting Minutes: Moved by L. Kolko, seconded by H. Burstein; minutes approved.

IV. Public Comment (2 minutes for each speaker)

Josh Squire w/Bike & Roll: Addressed Committee with concerns regarding bike, e-bike & e-scooter safety; enforcement of bike lanes & suggestions on how to proceed with Class 1 e-bikes, scooters, etc.

V. Special Guest: Commissioner Bhatt

 Comm. Bhatt briefly introduced herself & addressed the committee discussing projects and legislation she is spearheading that are relevant to the TPBPFC as well as other initiatives.
 The Committee offered support and assistance with her proposals regarding bicycle lanes, escooter/e-bike enforcement. The Commissioner suggested LTC's from the Committee when the time comes.

- Upcoming Commission Items
 - Route 115 Bus Replacement Going to Commission with proposal to change model to 14 Passenger Van on a fixed route & schedule. If approved at Commission Meeting, lead time to purchase vehicle is 30-45 days afterward. (Trans.)
 - Bicycle Lanes 72nd, 73rd St. connecting from Dickens to Beach Walk (Trans.)
 - Bicycle Lanes Ocean Dr. & 5th St.: Item from Comm. Suarez to close the gap and connect the lanes (Trans.)
 - Traffic Monitoring Expansion of initiative to implement year-round (Trans.)
 - Deployment of Traffic Control Measures & Enforcement in NOBE (Trans.)
 - Public Meeting: Bicycle Lane on Collins 63rd-75th St. on May 13, 2024 @ 5:30 p.m. (Trans.)
 - Standardization of Municipal Parking Garage Rates: Working to have all garages have the same rates by area, going for 2nd Reading (PKG.)
 - Reinstitution of Residential Parking Decals (PKG.)
 - P. Matos moved for LTC, L. Kolko seconded: TPBPFC does not support changing residential permits to return to a residential permit decal format. If the Commission moves to require decals, a more streamlined procedure that includes an automated solution should be in place for residents to validate residential parking permits to allow greater ease for residents.  procurement process to install Ziclas in the subject location. Painting will be done
 with FDOT standards. Expecting pricing from the contractor within the next few
 weeks. July-August 2024 proposed start date. Discussion held.
